Voting:

75% to pass-
Purpose is to provide opportunity for movement that overwhelming majority agree on, without allowing for a solitary veto power or ability to create change by simple force of wills.

Comments:

Dickie Patterson suggested that the Director have veto consensus power.

Jim Patterson stated that the 75% majority to pass is reasonable and would minimize objections from individuals.

Chuck Davoli stated that it is the Council's duty to work as a group and to come up with the best course of action. He agrees with 75% majority to pass.
